

**“2008 Cool Food For Kids Meijer Frozen Food Month”
Contest Rules**

NO PURCHASE NECESSARY.

ELIGIBILITY: No Purchase Necessary. You need not be present to win. Entrants for the Grand Prize must be at least 21 years of age and have valid drivers license to enter to win.
